JULY 6, 2025 + 14TH SUNDAY IN ORDINARY TIME

Jesus has just told the disciples in strong language about the difficulties of discipleship. He then appoints 72 men to go ahead of him to every place he plans to visit, proclaiming that the Kingdom of God is at hand. He sends them in pairs. In the Law of Moses two witnesses were needed for a credible testimony.

Despite the known challenges, they are to bring nothing with them, not even a money bag or sandals. They are to greet no one on the way so as not to be distracted from their mission. He instructs them on how they are to enter a house; their message simply "Peace." No special treatment should be expected, just a proclamation of the Good News. If the town will not receive them, they are to shake the dust from their feet and move on.

When they return from their journeys, they are rejoicing, amazed at their success. Even demons responded to Jesus' name. At the conclusion of this passage he assures them that they have been given power over the enemy and nothing will harm them, not even serpents and scorpions.

Today's Gospel message is faithful discipleship—its challenges, its difficulties, and its rewards. Sharing in the mission of Jesus is difficult, but everyone is called to do it. Even for us today, the harvest is plentiful. We should pray to the master of the harvest to send out workers for his harvest. God Bless and Peace be with you!

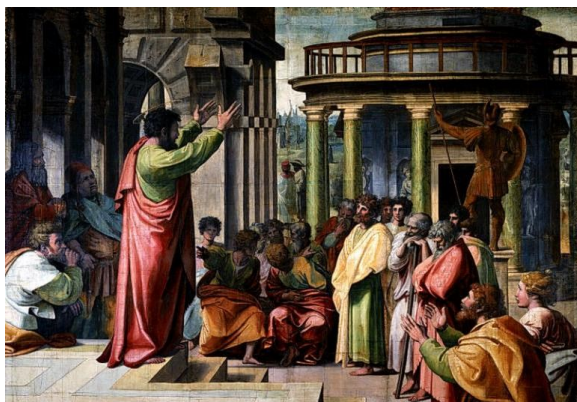
