## NOVEMBER 23, 2025 + CHRIST THE KING

This weekend we celebrate the centennial of the Solemnity of Our Lord Jesus Christ, King of the Universe. It was established by Pope Pius XI in 1925 as an antidote to secularism, a way of life which leaves God out of man's thinking and living and organizes his life as if God did not exist. The feast is intended to proclaim in a striking and effective manner Christ's royalty over individuals, families, society, governments, and nations.



Today's Mass establishes the titles for Christ's royalty over mankind: 1)

Christ is God, the Creator of the universe and hence wields a supreme power over all things; as scripture says, "All things were created by Him"; 2) Christ is our Redeemer, He purchased us by His precious Blood, and made us His property and possession; 3) Christ is Head of the Church, "holding in all things the primacy"; 4) God bestowed upon Christ the nations of the world as His special possession and dominion.

The image of Jesus Christ King of All Nations has been enthroned in the Narthex of our Church for permanent display. A larger image will soon be gifted to us and will be displayed in our new adoration chapel when it is built.

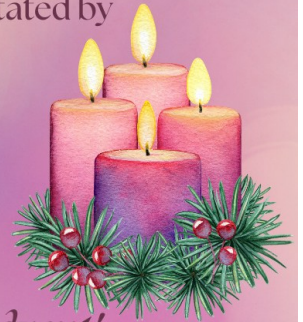
## What Christians Believe
