We would like to take this opportunity to congratulate Ethan McAnerney for accomplishing the rank of Eagle Scout. Roughly 2% of Boy Scouts achieve Eagle Scout. Requirements for the rank include earning at least 21 merit badges (Ethan earned 42), demonstrating Scout Spirit, an ideal attitude based upon the Scout Oath and Law, service and leadership. Along with those requirements is an extensive service project that the Scout plans, organizes, leads and manages. For Ethan's Eagle service project he primed and painted the heavily water and age stained ceiling in the budget shop basement that is used by Seven Dolors CYO and Knights of Columbus. It has brightened the meeting space considerably. Additionally he earned an Eagle bronze, silver and gold palm. Eagle palms are earned for additional merit badges earned above and beyond the required amount to earn Eagle Scout. Other accomplishments include being a patrol leader twice, assistant senior patrol leader twice, senior patrol leader twice, 133 nights of camping, 53 service hours and 80 miles of hiking. Ethan has been a life-long member of Seven Dolors and is a graduate of Manhattan Catholic Schools. His parents are Paul and Maria McAnerney and he has a brother (Thomas) and a sister (Rebekah).
The family have been members of Seven Dolors since 1997.
