+Reclaiming Life – faith, hope and suicide loss:

The suicide of a loved one can have a profound and sometimes devastating impact on those left behind, called suicide survivors. Bereavement after suicide may entail high levels of disorientation, guilt, regret, anger, and trauma. Survivors sometimes struggle with the social stigma often placed on suicide. All of this makes surviving the suicide of a loved one a potentially life-changing ordeal that requires all of the resilience that a survivor can muster, and all the support that family and a faith community can provide for them. Join us at 6:30p.m. on July 26 and August 2 as the topic of suicide survivors is presented through a Christian perspective using a video and discussion afterwards.
